Dear Adult Education Superintendents:

FUND 11: ADULT EDUCATION

I hope this letter finds you well. I am writing to remind you of an important compliance matter regarding the management of funds allocated to Adult Education Programs within your district.

As you are aware, the funding designated for Adult Education Programs commencing with California Education Code (EC) Section 84900 is subject to specific financial regulations. It is imperative that state, local, and federal funds that are restricted or committed for adult education programs are deposited into a separate account specifically dedicated to Adult Education purposes. Local education agencies are required to use Fund 11: Adult Education Fund. This ensures transparency and accountability in the use of these funds, which are crucial for supporting our adult learners and the overall success of our education initiatives.

The separation of these funds is not merely a best practice but a legal requirement. The designated funds must be utilized exclusively for the purposes outlined in the Adult Education Program guidelines. This includes, but is not limited to, instructional costs, program development, resources for adult learners, and any other expenditures directly related to adult education and outlined in the California *EC* sections <u>52616</u> and <u>52616.4</u>.

EC Section 84913 outlines the allocable use for state adult education funds. EC Section 84914 sets forth the process for the allocation of these funds through the consortium annual plan and budget development which each district agrees to through the annual fiscal approval certification. Furthermore, EC Section 84901 defines an "Adult" to mean a person 18 years of age or older and that these funds shall only be used to support adult students in the outlined programs. Students under the age of 18 may be enrolled in adult education per EC 52500.1. A school district shall clearly demonstrate that the costs of instruction for pupils under 18 years of age enrolled in an adult education program, course, or class described in EC 84913(a) are from another allowable fund source or sources.

Proper management and allocation of these funds not only comply with statutory requirements but also reflect our commitment to maintaining the integrity of our educational programs. Ensuring that these funds are used appropriately is essential for sustaining the quality and effectiveness of the Adult Education Programs we offer.
